



2021-2022 Membership Agreement

Quest Boosters (referred to herein as “we,” “us” and “our”) sponsors a scrip program through Great Lakes Scrips Center (<https://www.shopwithscrip.com/>) that allows members to purchase scrip. The scrip you purchase through our program generates rebates from the participating retailers. These rebates will be shared equally between Quest Boosters and members. Cash distributions will be made in August based on rebates accumulated from August 1, 2021 - July 31, 2022. Only Quest Boosters member families will receive cash distributions. The parties agree to as follows:

Non-participation in this program will not preclude team member families from benefitting from funds raised and allocated to team travel, meet fees, and other forms of financial support the Quest Booster Board of Directors deems appropriate throughout the membership year.

You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover the checks or ACH transfers you issue to pay for your scrip. We make no representations or warranties of any kind with respect to the scrip. This agreement continues unless replaced by another, and can be terminated by either of us upon 60 days advance notice to the other. **The \$30 Quest Booster membership is non-refundable.**

Travel Reimbursement Eligibility:

1. To qualify for travel reimbursement in 2022, each swimmer benefiting would have needed to raise \$250 in 2021. This is a per swimmer requirement, not family. This could have been achieved through donations for Swim-A-Thon or other organized fundraising events sponsored by Quest Boosters and flat donations in 2021. In addition to the fundraising requirement per benefiting swimmer, each family would have to be a current and paid Booster Member for 2021/2022.

2. Swimmers are expected to compete at ALL Team Scored Championship Meets for which they are qualified. If a Quest swimmer or family chooses not to compete (self), then it will be justified not to offer reimbursement through Quest Boosters for higher level competitions. Quest Swimmers are expected to not only compete for their own individual performances but also that of the Team and Others. Competitive Excellence is the purpose of our team...to “strive with others” to enable ALL Quest Swimmers and Families to rise to the highest levels possible. Quest Swimmers WILL give their best efforts in competition at ALL times. The Head Coach will have final approval on Quest Swimmer or Families final reimbursement status.
